Guidelines for the Submission of Prepared Testimony of Witnesses

Committee requirements:

- 1) 150 printed copies.
- 2) Electronic copy, via e-mail attachment or floppy disk. Electronic copy of testimony may be in Microsoft Word or WordPerfect, compatible with Windows 2000. Additionally, the Committee will accept testimony in PDF if it is in "unprotected format." The unprotected format is necessary for posting to our website in accordance with Section 508 of the Americans with Disabilities Act.

Delivery:

Electronic copy should be sent via e-mail to the Committee Staff Contact, 24 hours before the hearing. Physical media (printed copies/floppy disks) should be delivered to 309 Cannon House Office Building, 24 hours before the hearing.

Heading:

Format:

Single spacing
Normal capitalization of titles, sections, headings
Soft returns in formatting unless at the end of a paragraph
No indentation at the beginning of paragraphs

Floppy Disk Format:

If you are submitting your testimony on a floppy disk, please use a 3-1/2" formatted (HD/DS) MS-DOS disk. Label the disk with the witness' name, date of hearing, and brief title of hearing. Do not send zip disks, jaz disks, tapes, or Macintosh formatted disks.

Things to avoid:

Underlining (in web formatting, that denotes a hyperlink).
Footnotes
Capitalization of blocks of text or entire sentences

Additional requirements for non-Government witness:

House rules require the attachment of a witness disclosure statement – "Truth in Testimony" to the printed copies of testimony.

Please note:

The Committee does not accept testimony from uninvited witnesses.
